6. Letters of Evaluation

ADD A LETTER OF EVALUATION

Many medical schools determine whether or not an applicant has met their letter of evaluation/recommendation requirements by the type of letters they receive in support of an application. For example, a medical school may require a committee letter OR three individual letters in support of your application.



- Committee Letter: A committee is a letter authored by a pre-health committee or pre-health advisor and intended to represent your institution's evaluation of you. A committee letter may or may not include additional letters written in support of your application. A Committee Letter is sometimes called a composite letter.
- Letter Packet: A packet or set of letters assembled and distributed by your institution, often by the institution's career center.
- Individual Letter: An individual letter refers only to a letter authored by, and representing, a single letter writer. **If you have already included an individual letter within either a committee letter or letter packet, you do not need to add a separate entry for the individual letter.**




Criminal Background Checks

- Participating medical schools have Criminal Background Checks on their accepted or waitlisted applicants facilitated by the AAMC
- Applicants will receive an e-mail notification from Certiphi Screening, Inc., initiating the background check
- Applicants have 10 calendar days to review their report for irregularities, after that time it will automatically be sent to the medical school(s)
- There is no additional charge to the applicant for this service



Multiple Accept Data

- Medical schools cannot view the number or names of other schools that you have applied to
- Medical schools have access to:
 - Multiple Accept Data (**February 10**)
This report allows medical schools to see other schools to which an applicant they have accepted is also currently holding an acceptance decision
 - The National Acceptance Report (**April 1**)
This report lists all applicants with a current Acceptance or Matriculated action

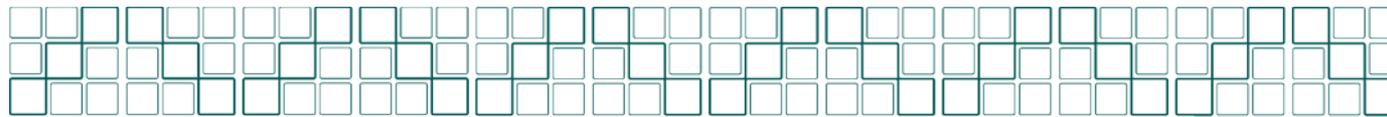

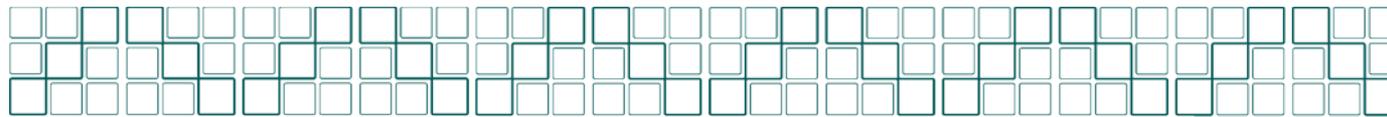


Table 17: MCAT Scores and GPAs for Applicants and Matriculants to U.S. Medical Schools, 2003-2014

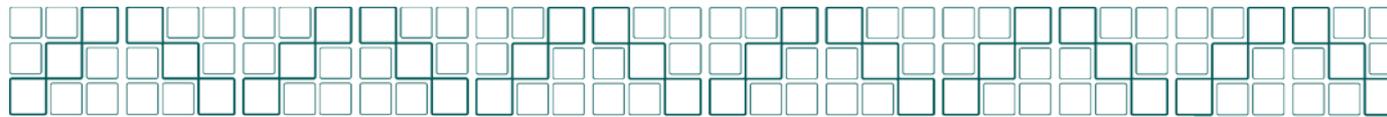

- Don't write about the patients!!! Write about the physicians!

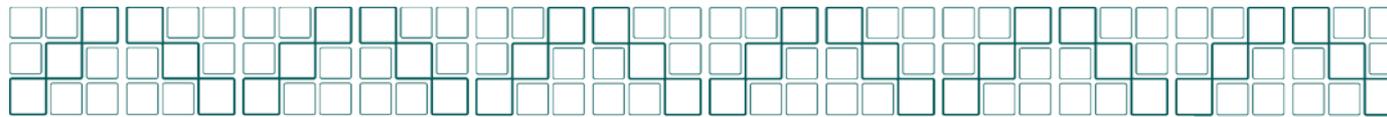


If you do not want to talk about something in an interview, do not write about it in your Personal Statement!

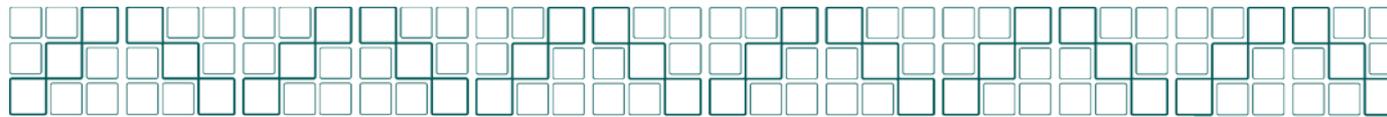

- *Real* clinical experience in a hospital setting
 - Observe and talk about physicians, not patients
- Experiences with leadership and accomplishment
- Meaningful to you and has relevance in some way to your chosen career goal
- Display the *other* interests that help define who you are!

Postbaccalaureate Premedical Programs

A number of schools offer postbaccalaureate premedical programs to assist individuals to pursue a medical career after they have already received a Bachelor's degree.

The purposes of these programs vary. Some are designed for persons wishing to change careers; these individuals have not yet completed the science courses required for medical school application. Other programs are designed for persons wishing to enhance an existing academic record; these students have taken the requisite courses, but need to improve their GPAs to increase the competitiveness of their medical school applications. Still other programs are specifically designed to assist persons from groups currently underrepresented in medicine or from educationally or economically disadvantaged backgrounds.

This searchable database enables you to search according to program type and other program characteristics.

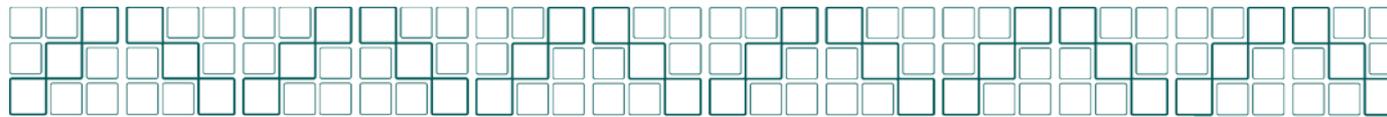

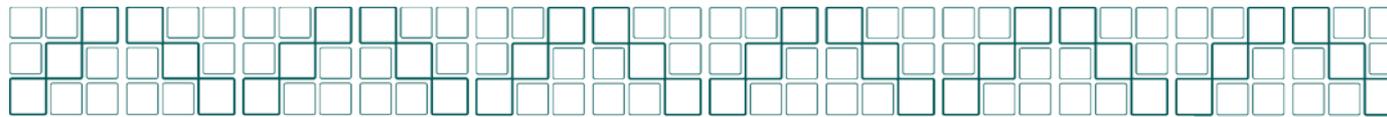

Early Decision Program?


- The Early Decision Program (EDP) gives medical school applicants the *opportunity to secure an acceptance* from one EDP-participating medical school by October 1, while still allowing sufficient time to apply to other schools if you are not accepted (????!!!!)
- Apply to **only one** U.S. medical school by the stated deadline date (August 1 for schools that participate in AMCAS);
- Attend only this school if offered a place under the EDP.

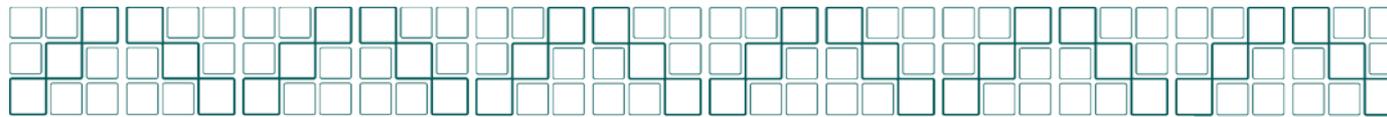

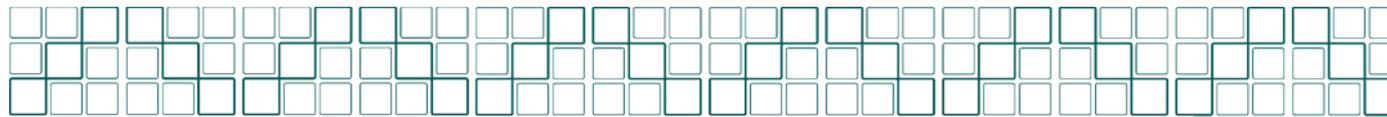
National Health Service Corps Scholarships:

- **The scholarship pays tuition, fees, other educational costs, and provides a living stipend in return for a commitment to work at least 2 years at an approved outpatient facility in a medically underserved community.**
- The scholarship can be awarded for as many as 4 years. With each year (or partial year) of support beyond the first year, the student agrees to provide one additional year of service, with a maximum of four years.



National Health Service Corps Loan Repayment Program:

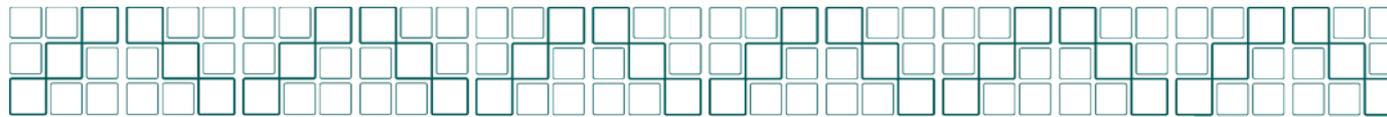
- **Primary care medical, dental and mental/behavioral health clinicians can get \$50,000 to repay their health profession student loans in exchange for a two-year commitment** to work at an approved NHSC site in a high-need, underserved area. The payment is made at the beginning of service so you can more quickly pay down your loans. Approved sites are located across the U.S., in both urban and rural areas.
- After completing your initial service commitment, you can apply to extend your service and receive additional loan repayment assistance.



M.D. – Ph.D. 2014

- 1,891 applicants and 626 acceptances (33.1%)
(2013: 45.2%)
- These programs are for applicants who will be research P.I.s
- Applicants must submit 3 essays with the MCAT
 - Why be a physician?
 - How does an M.D. education benefit your research interests and career?
 - Discuss your research career

(You need to be super to get serious consideration.)



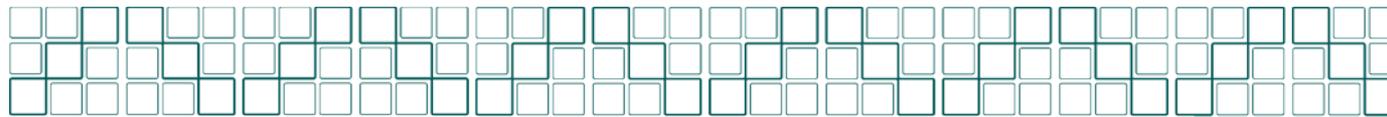

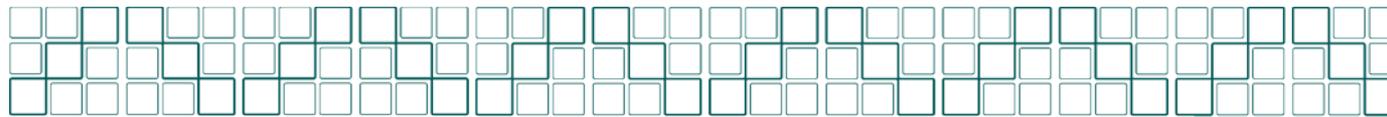
Take home messages

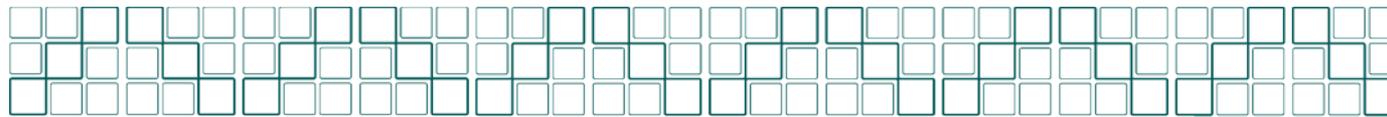
